## Queens Tournament Rules

1. This tournament is certified by United States Bowling Congress.
2. This event will be conducted on a scratch basis. Total pin fall will determine the step ladder final.
3. Entrants must hold a minimum average of 160 or higher for 21 games or more in a certified USBC league for 2018-2019 winter season or the 2019 summer season.
4. Women members of the Union County NJ USBC are eligible to compete in this tournament. Non-members may enter by paying an associate fee of $\$ 10.00$ to the UC NJ USBC. All entrants must produce their USBC certification card. No junior certified bowlers will be permitted to bowl.
5. Bowlers will bowl 5 games moving one pair to the right after each game. Top 5 women, total pin fall, will advance to stepladder Single elimination final. In the step ladder, $5^{\text {th }}$ place and $4^{\text {th }}$ place finishers will bowl each other. The winner of that match will bowl the $3^{\text {rd }}$ place finisher. The winner of that match will bowl the $2^{\text {nd }}$ place finisher. That winner will bowl the $1^{\text {st }}$ place finisher for the title.
6. In the event of ties for the last place in the qualifying round, a two frame $\left(9^{\text {th }} \& 10^{\text {th }}\right.$ frame) roll off will be held to determine the last qualifying position(s). In the finals, a two frame ( $9^{\text {th }} \& 10^{\text {th }}$ frame) roll off will also be held to determine the winner.
7. All prize fees will be returned $100 \%$ to the participants.
8. USBC Rule 319D (reporting of prior prize winnings) is waived.
9. USBC Rule 319E (average adjustment for entry) is waived.
10. All other USBC rules will apply. Tournament committee reserves all rights.
