Tournament Rules

- Only certified members of the Union County NJ USBC of the age of 50 and above at the time of bowling are eligible to compete in this tournament. This is a 100% Handicap Singles Tournament. The Handicap is 100% of 230 without any limit.
- There will be three classes of competition: Class A – 190 & up, Class B – 150 – 189, Class C 149 & lower. The prize ratio shall be at least one in five per class.
- Averages will be used in the following order based on a highest average minimum of 21 certified games in the Union County NJ USBC average book:
 - Highest 2022-2023 Winter Season
 - If no 2022-2023 average, you will use your highest 2023-2024 average minimum 21 games as of March 1, 2024, and MUST PROVIDE AVERAGE VERIFICATION with entry form.
 - Summer league averages will not be accepted.
- USBC Rule 319A-3 shall apply. It shall be each bowler's responsibility to verify the accuracy of his/her average for this tournament. Failure to use the proper average or make the average correction prior to the completion of the first game shall disqualify the entry if a submitted average is lower than the entered average. When an average is submitted higher than it should be and not corrected by the completion of the first game that submitted average shall be used for tournament participation. USBC Rule 319C – bowler must provide rerated averages prior to bowling if rerated in another tournament, including rerated average and date of tournament. USBC Rules 319A-2, 10 pin increase, 319D Reporting of Prizes and 319e Rerating rule all shall be waived,
